

Oluwatoyin Temitayo Ogundipe is a Professor of Botany in the Department of Botany, Faculty of Science, University of Lagos. He holds a Ph.D. Botany (Ife) and MBA (Unilag). Professor Ogundipe has attended training at the University of Johannesburg, South Africa, University of Reading, U.K., University of Cambridge, U.K.; Harvard University, U.S.A. and Kunming Institute of Botany, China. His area of research includes, but not limited to Molecular Plant Taxonomy/Biosystematics, Forensic Botany, Cytogenetics, Ethnobotany, Paleobotany and Ecological conservation.

He has over ninety (90) publications in accredited academic journals and has co-authored eight (8) books. His research

my of some plant genera and using the anatomical features in the identification of sterile and fragmentary plant specimens. His publications show that he has been engaged in the recording of the general anatomy of plant species and assembling anatomical features, which may be used along with other features for enhancing taxonomic knowledge of the plant and establishing an identification system for some of these plant species.

He has also been involved in exploration and testing of herbal drugs for their medicinal and antimicrobial properties. Also, some of his publications have shown the use of pollen and spores as sources of honeybees, in control of allergies and in determination of climate change and changes in land cover over the years.

Furthermore, he has been able to show the genetic diversity and relationships between different plant taxa, as well as assess phylogenetic relationship among plant populations using molecular techniques. He is currently involved in the Molecular Study of Arid Plants, Orchids in Nigeria, Acha plants, allergic studies etc. His Publications have been very relevant in botanical research with 370 citations from 2009 till date. He is a two-time recipient of the Faculty of Science researcher award and many other local and international awards. He has effectively supervised 18 Ph.D. and 45 M.Sc students.

As a result of his passion for his profession, Professor Ogundipesuccessfully transformed three empty rooms into fully equipped laboratories. He has attracted research grant from different agencies worth over N187m, \$3m and £28,000. Two of his research work in collaboration with other scholars are currently undergoing the process of patenting.



Profile of the Vice Chancellor (Contd.)

Professor Ogundipe understands the need for multi- disciplinary collaboration, thus, he has been working with other scholars from different discipline within the University and other institutions locally and internationally. He is a Fellow of the Nigeria Academy of Science; Fellow, Royal Society of Biology, London; Fellow, Leadership for Environment & Development; Fellow, Linnaean Society of London; Fellow, Institute of Security; Fellow Institute of Corporate & Business Affairs Management, Nigeria; and National President, Botanical Society of Nigeria.

Professor Ogundipe has held different administrative positionssince joining the University of Lagos in 1990. He was on time Head, Department of Botany where he introduced sweeping reforms at the Department. As Sub-Dean, Faculty of Science he began the computerization of students' results and also attracted collaboration from multinational corporations. He later became the Dean, School of Postgraduate Studies where he attracted a lot of town-gown relationships and led the computerization of the entire process in the School. He was also the Director Academic Planning Unit and in 2016 was appointed the Deputy Vice-Chancellor (Academics & Research). Professor Ogundipe is currently the Vice-Chancellor of the University.

Since taking over on November 12, 2017, there has been a renaissance in demand driven research in the University, and town-gown relationship is being renewed. Particularly, he has paid so much attention to Entrepreneurship that he is leading University of Lagos presently to turn all disciplines to Entrepreneurship oriented courses. He is passionate that graduates of University of Lagos will be job creators before finishing their degrees rather than joining the queue for jobs that actually do not exist. He is pushing this new frontier, working assiduously to promote entrepreneurship amongst students and set aside seed-funds for Campus Start-ups that are launching innovative product or service to solve the societal social problems. He has announced the readiness of University of Lagos to ensure that all students in all Faculties now mandatorily complete Entrepreneurship training alongside their degreesbefore graduating. More novel is the readiness of the University to support successful students from this Entrepreneurship program to start-up and settle down into their chosen enterprises with both financial and technical supports. This is the first Vice-Chancellor of Nigerian Universities taking this bold step and innovative initiative. His effort recently won the University of Lagos a Centre of excellence of the Africa Research Universities Alliance (ARUA) for Unemployment and Skills Development which has now become an Entrepreneurship Research and Innovation Hub for creating solutions that will address unemploymentand poverty in Africa.

Outside the University of Lagos, Professor Ogunsola has served in various capacities nationally and internationally. She was the Faculty Secretary (2002-2007) of the Faculty of Pathology, National Postgraduate Medical College of Nigeria and served on the Management Boards of the Lagos University Teaching Hospital (LUTH), National Hospital Igbobi Lagos and the National Psychiatrist Hospital Yaba. She is currently a member of Nigeria's Expert Review Committee (ERC) on Polio Eradication and Routine Immunization. She is the National Nominee to WHO International Health Regulations (2005) Roster of experts on Infection Control 2017-2020, a member of the WHO Technical Working Group on Infection Prevention and Control, Member of the Global Infection Prevention and Control Network. She was the Scientific Chairman of the Astrazeneca Research Trust till 2016. She is currently the Chairperson of The Infection Control



African Network. More recently She, with her team of experts, developed an Infection prevention and control curriculum for the training of IPC Practitioners in Nigeria.

She is on the Board of Trusteesof K'arale, and the Foundation for Development Initiatives both of which are Non-Governmental organisations involved in providing health to poor communities and development respectively; She is on the board of Vivian Fowler Memorial College for Girls and was a member of the Medical and Dental Council of Nigeria where she served on the Council's Medical Tribunal and Medical Education Committee.

Professor Ogunsolahas supervised over50 students at the Masters level, Supervised and co-supervised8 PhD students, supervised and co-supervised 15 resident doctors both in Medical microbiology and other specialties. She has participatedin and presented over 80 papers at national and international conferences and workshops, She hasover 100 publications in learned journals and books on Antibiotic Resistance, Infection Control and HIV. Her areas of interest include the Prevention and Control of infectious disease and antibiotic resistance.


